Fixed interest rate declared by Sagicor that is guaranteed for one year.

#### S&P 500<sup>®</sup> INDEX STRATEGY; 1 YEAR TERM WITH CAP (Indexed Strategy 1)

One year point-to-point indexed strategy linked to the S&P 500<sup>®</sup> Index.

### GLOBAL MULTI-INDEX STRATEGY; 1 YEAR TERM WITH PARTICIPATION RATE

One year point-to-point indexed strategy that utilizes the S&P 500°, Euro Stoxx 50° and Hang Seng® indices.

## Features & Benefits

#### APPLICATION

We offer an easy electronic application process that is available when you work with a qualified Sagicor Sales representative.

#### BONUS

A 4% bonus (100% vested day 1) is automatically added to the single premium paid at issue.

#### DIVERSITY

Select from allocation options with a distinctive and globally diverse choice of index strategies.

#### **ACCOUNT VALUE PROTECTION**

The index-linked interest that is credited to you will never be less than 0%. This means a downturn in the market index cannot decrease your account values.

#### **WITHDRAWALS**

Withdrawals<sup>1</sup> are allowed at any time and may be subject to a surrender charge.

#### PENALTY FREE WITHDRAWALS

Beginning in the second contract year, you may withdraw<sup>1</sup> up to 10% each year of the account value without a surrender charge. If the 10% is not withdrawn, it will be cumulatively added to the next year's maximum free withdrawal percentage, up to 50%.

Under the Penalty Free Withdrawal provision, if you qualify<sup>2</sup> for the nursing home facility or confined care facility<sup>3</sup> benefit, you can withdraw 100% of the contract value without a surrender charge. This provides you with peace of mind knowing that you have full access to your money at a time when you may need it most.

#### **GUARANTEED MINIMUM WITHDRAWAL BENEFIT**

Each year, between contract years 13 through 32, we will calculate a withdrawal that you may take during the year. You are not required to withdraw this amount and any unused amount will be applied to the following year. You will be entitled to withdraw this amount even if it exceeds the account value.

#### **ANNUITIZATION/PAYOUT OPTIONS**

There are several options for guaranteed income such as a fixed payment amount, payments for a fixed number of years, or payment guaranteed for life.

#### TRANSFERS/REALLOCATIONS

Transfers among the crediting options are permitted at the end of each 1-year term period.

#### FREE LOOK GUARANTEE

If the contract is cancelled within 30 days after delivery, your premium paid, less any withdrawals and surrender charges, will be refunded. Any bonus credited will not be refunded.

#### CHARGES

No front end charges or annual fees.

#### **TRIPLE TAX DEFERRED GROWTH<sup>4</sup>**

Your ability to earn interest is compounded because:

- Your premium and bonus will earn interest
- Your earnings on the premium and bonus will earn interest
